How does the Cintas program work?



IN THE CINTAS MANAGED PROGRAM, EACH WEARER IS ISSUED:



CUSTOMER'S ROLE:

- After Cintas delivers two different color sets of gloves, Customer will distribute to its employees gloves in one color set (i.e. yellow) for the initial term and store the gloves in the second color set until they are due for rotation (i.e. black) for the second term.
- Customer shall determine the length of time appropriate for each term prior to gloves being distributed; the initial term shall not exceed six months.
- Customer shall train employees on identifying potential glove defects that would require gloves to be decommissioned by the employee or employer prior to the end of the initial term.
- After the initial term ends, Customer shall gather all gloves from the initial color set (i.e., yellow) and distribute the second color set to its employees.
- Customer packages all gloves that require electrical testing from first set, completes NSA Glove Retest Form, and then ships gloves to National Safety Apparel in Cleveland, Ohio.
- Customer is responsible for replacement costs associated with rubber voltage gloves that cannot be recertified due to destruction, failure to return, or glove damage that surpasses normal wear and tear.
- Communicating with Cintas the request for new gloves to be added to the program (whether due to replacement, new employees, or for other reasons).

CINTAS' ROLE:

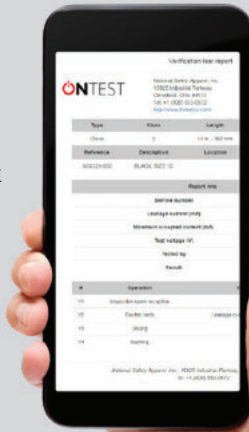
- Cintas will pay for the testing recertification at the end of each term, less the cost of shipping.
- Cintas will replace all gloves, at no cost to the customer, that fail recertification due to normal wear and tear.
- Cintas will also bear the shipping charges for the shipment of gloves from NSA to the customer, both on program initiation and after each testing recertification.
